At the age 25, I found myself on the floor in the darkroom crying and wishing for the courage to commit suicide, because I could not handle the whole pressure of my new life. Back that day I did not know that it would be my bifurcation point that will turn my life toward the decision to become a mental health counselor.

At that time I recently immigrated to Mexico, I had a newborn child with very limited help, I had postpartum depression, and I was passing through an identity crisis. My coping mechanism to deal with present issues was food. It was fast, easy, legal, and innocent at the first glance. So almost daily basis I was desperately running for the whole cake shaming myself on the way to the store for being so weak, then eating all of it trying to shut up the voice of the inner critic saying how miserable I am, then crying and punishing myself for getting fat instead of fixing my problems. I did understand that I was running in a circle but could not break it alone.

Things started to change with a help of a therapist. She explained to me that my overeating is not a lack of willpower issue. An eating disorder is a disease that was forming for a long time by many factors and requires complex long-term treatment.

Since then I started my journey of personal recovery that is not over yet. I would say I could figure out 80% of my unconscious patterns and replace them with healthier behavior. Introspection became my habit and I got really absorbed by studying mental health. That is one of the reasons why I am pursuing MS Counseling at Prescott College. I enjoy learning deeper about the human mind, psycho, history of addictions, and modern prerequisites for just appearing ones. I want to extend my hand of help to others who still suffer from eating disorders and probably even do not realize it.

Another reason to justify my choice of career path is my Overeaters Anonymous experience. As an active member of this society, I found for myself that serving the community is one of the keys to maintaining myself in remission. I can see how widely problems with food are spread in our modern society, how underestimated they are, and even stigmatized. It is clear for most of us that alcoholics and drug-addicted people cannot "just stop doing it", but it is not the same for people who struggle with food. I know from myself how harsh and destructive the current diet culture is. It

pushed me outside of feeling normal and forced me to feel constantly guilty for not fitting the standard. But the solutions that are offered by mass-market are delusional, they just drive suffering people in the circle of guilt, shame, and willpower, which may create short-term results but not fix the root of the issues. That is why I want to provide professional help as a counselor relying on scientifically proven information and studies.

By getting a degree in Counseling and using my multicultural experience I want to elaborate on new methods to help people cope with contemporary addictions. I hope to raise the awareness of the importance of mental health for people struggling with eating disorders and their family members. I want to develop educational programs for parents that can help them to see damage-causing scenarios they probably pass from generation to generation and that lead directly to clutches of eating disorders. In cooperation with nutritionists promoting scientifically-based information, I wish to help families find new behavior models that work specifically for them and their kids what in general will build a healthier future generation.


